# **Proposed Transportation Improvement Program Amendment**

# **Amendment Timeframe**

The May 2024 amendment to the 2024-2029 Walla Walla Valley Metropolitan and Regional Transportation Improvement Program (M/RTIP) includes the years 2024 through 2027.

# **Projects Included**

The May 2024 Amendment proposes increase in funding and changing for planned to secured for PE and CN phase to the Washington State Department of Transportation projects. Additional project details also shown in <u>Appendix A</u>.

# **Washington Department of Transportation**

**Project Name:** 512501Z36 - SR 125 Spur/N 13th Ave to Myra Road - ADA Compliance **Amendment:** The amendment indicates that PE changed from Planned to Secured.

Improvement: Upgrade existing curb ramps to meet ADA Compliance. This project will upgrade the

curb ramps to meet current standards, improving accessibility for all pedestrians.

**Total Estimated Project Cost:** \$294,853

Project Name: 501219C36 - US 12/Isaacs Ave Bridge - Deck Rehabilitation

**Amendment:** The amendment indicates there is an increase in funding for PE and CN phase by \$19,232 and \$243,880 respectively. PIN total increased \$273,112 from \$2,667,296 to \$2,940,408. CN changed from Planned to Secured.

**Improvement:** Repair and resurface the existing bridge deck to maintain the structural integrity, continue safe operation of the highway and extend the life of the bridge.

**Total Estimated Project Cost**: \$2,940,408

Project Name: 501203A36 - US 12/Wallula to Nine Mile Hill - Build New Highway

**Amendment:** The amendment indicates there is additional funding to the RW phase by \$4,740,000 from \$14,750,000 to \$10,010,000. PIN totals decrease \$11,030,000 from \$219,030,000 to \$208,000,000. PE funds of \$3,300,000 out of \$6,360,000 have already been obligated.

**Improvement:** Adding capacity, reducing the risks of collisions, and improving economic vitality by completing the four-lane of US 12 FROM Tri-Cities to Walla Walla.

**Total Estimated Project Cost:** \$208,000,000

Project Name: 573001H36 - US 730/4.1 Miles N of Oregon Border - Rockfall Prevention

**Amendment:** The amendment indicates that there is CN phase by \$8,265 from \$200,802 to \$209,067. PIN total increased \$8,266 from \$252,972 to \$261,238. CN changed from Planned to Secured. PE funds have already been obligated.

**Improvement:** Removal of loose rocks and installation of permanent ground anchors and slope protection netting. These measures will reduce the potential for collisions by reducing the risk of falling rocks reaching the roadway.

**Total Estimated Project Cost: \$261,238** 

**Project Name:** 573001I36 - US 730/4.4 Miles N of Oregon Border - Rockfall Prevention **Amendment:** The amendment indicates that there is CN phase by \$66,136 from \$1,606,617 to \$1,672,753. PIN total increased \$73,437 from \$1,932,061 to \$2,005,498. CN changed from Planned to Secured. PE funds have already been obligated.

**Improvement:** Removal of loose rocks and installation of permanent ground anchors and slope protection netting. These measures will reduce the potential for collisions by reducing the risk of falling rocks reaching the roadway.

**Total Estimated Project Cost:** \$2,005,498

**Project Name:** 512501Z36 - US 730/5.2 Miles N of Oregon Border - Rockfall Prevention **Amendment:** The amendment indicates that there is CN phase by \$7,184 from \$174,510 to \$181,694. PIN total increased \$7,184 from \$307,302 to \$314,486. CN changed from Planned to Secured. PE funds have already been obligated.

**Improvement:** Removal of loose rocks and installation of permanent ground anchors and slope protection netting. These measures will reduce the potential for collisions by reducing the risk of falling rocks reaching the roadway.

**Total Estimated Project Cost:** \$314,486

# **Project Prioritization**

The projects programmed for implementation in the Walla Walla Valley region (see map in <u>Appendix B</u>), were selected and prioritized using a performance-based and data-driven process that considered project readiness, safety, system preservation, quality of life, connectivity, and efficiency impacts.

# **Important Findings**

# **Funding Availability**

The secured projects in the 2024-2029 M/RTIP must have committed sources of funding. Close coordination with the Oregon and Washington State Department of Transportations (ODOT and WSDOT), as well as other federal or state granting agencies, ensures that the M/RTIP is fiscally constrained.

In general, availability for Walla Walla Valley-specific Surface Transportation Block Grant (STBG), Transportation Alternatives (TA), and Carbon Reduction Program (CRP) funds is tied to allocation provided through WSDOT. The following tables summarize the funding assumptions for the STBG, TA, and CRP programs from 2024 through 2027.

Funding availability for other sources of funds are tied to each project sponsor's demonstration of specific funding awards, which are routinely verified by WWVMPO/SRTPO staff.

Lastly, the DOTs will also review the amendment and the associated fiscal constraint prior to inclusion into their respective STIP during this amendment cycle.

# Consistency with Local, Regional, and State Plans

The projects included in the May 2024 Amendment are consistent with the goals and objectives of local comprehensive plans, the Walla Walla Valley Metropolitan and Regional Transportation - 2045 Plan, and the Oregon and Washington State Transportation Plans.

# **Air Quality Conformity**

As a part of its compliance with <u>40 CFR 93</u>, which governs air quality conformity, the WWVMPO/SRTPO certifies that these amended projects will resurface and/or rehabilitate pavement, update pavement markings, and add guardrails. According to <u>40 CFR 93.126</u>, these projects are therefore exempted from the requirement to determine air quality conformity.

The agency thus finds that the projects included in this May 2024 Amendment to the 2024-2029 M/RTIP will not cause air quality to degrade to levels that would be in violation of the allowed standards for particulate matter with a diameter less than or equal to ten micrometers ( $PM_{10}$ ).

# **Public Involvement**

Citizens and interested parties are provided with the opportunity to comment on any M/RTIP amendment, as required under the IIJA Act.

The public review period for the May 2024 Amendment to the 2024-2029 M/RTIP will be held from April 2 through April 15, 2024. Public notices announcing the availability of the draft will be published in the newspapers of record. An electronic copy will be posted on the WWVMPO website at <a href="https://wwwmpo.org/public-participation.html">https://wwwmpo.org/public-participation.html</a>.

Public comments received are included in Appendix C.

# Conclusion

After review and analysis of the proposed changes and additions, and as called out in the previously mentioned findings, WWVMPO/SRTPO concludes that the May 2024 Amendment to the 2024-2029 M/RTIP is in compliance with the requirements of RCW 47.80.023 which governs regional transportation planning, 23 USC 134 and 49 USC 5303 which govern the metropolitan transportation planning process, as well as 42 USC 7401 (et seq.) and 40 CFR 93 which govern air quality and associated conformity determination.
